## **Энергетическое сотрудничество России и Евросоюза в зарубежной литературе**

Отношения России и Евросоюза в энергетике привлекали рекордное количество исследователей за рубежом, в сравнении с изучением других сфер сотрудничества России и ЕС. Это обусловлено, главным образом, тем, что в данной сфере Евросоюз особенно чувствует свою уязвимость в диалоге с Россией. Если в вопросах экономического сотрудничества и визовой политике мяч, скорее, на стороне Брюсселя, который использует свои конкурентные преимущества для давления на Россию, то в энергетике все воспринимается наоборот. В этой связи закономерным стал и фокус на природном газе как основном «болевом» аспекте, поскольку в данной сфере Россия и ЕС инфраструктурно связаны, а диверсификация поставок осложнена. В то же время крупные объемы поставок нефти, нефтепродуктов и ядерных материалов из России в ЕС вопросов не вызывали, поскольку переключение на альтернативных поставщиков здесь менее проблематично, а соответствующие рынки глобальны.

Если в российских исследованиях энергетических связей доминировала эмпирика, то в Евросоюзе его доля была значительно ниже, а энергетические отношения с Россией использовались для построения или тестирования различных теорий. Прежде всего, надо отметить использование концепций зависимости, взаимной зависимости, международного

общества и комплексов безопасности.<sup>1</sup> Кроме того, в исследованиях энергетических связей России и Евросоюза прочно обосновался термин «геополитика».<sup>2</sup>

Постепенно выкристаллизировались две традиции, два контрастирующих подхода к отношениям России и Евросоюза в энергетике. Первый, основанный на рыночной экономике и институтах, отталкивался от либеральной традиции международных отношений, призывал к выстраиванию между Россией и Евросоюзом отношений, основанных на рынке и праве.<sup>3</sup> В связи с этим можно также отметить и исследование роли Договора к Энергетической хартии, а также роли Евросоюза по экстернализации своего законодательства.<sup>4</sup> К этой же традиции надо отнести исследования сближения

законодательства России и Евросоюза в области энергетики, модальностей этого процесса и его последствия.<sup>5</sup>

Второй, геополитический, исходил из реализма, утверждал, что в силу специфики России или международных отношений в целом выстраивание отношений только на рыночных основах невозможно.<sup>6</sup> С общей секьюритизацией исследовательской повестки отношений России и Евросоюза, а также растущими опасениями в отношении действий Москвы сдвиг закономерно произошел в сторону геополитики. Особую озабоченность в этой связи вызывали страны т.н. общего соседства, а также связанные с ними транзитные риски.<sup>7</sup> Внимание зарубежных ученых также было сфокусировано на различиях в интересах стран-членов, способности России манипулировать этими различиями, а также на вариантах решения данной проблемы.<sup>8</sup>

Исследовались также предпосылки различий во взглядах России и Евросоюза на энергетическое сотрудничество. Причем в данном случае применялся богатый спектр различных теоретико-методологических подходов.<sup>9</sup> Ряд российских исследователей также публиковали работы, направленные на разъяснение позиции России,<sup>10</sup> представление мотивации энергетических компаний и официальных властей.

За рубежом присутствовали и исследования более эмпирического характера, посвященные тому, как изменения в законодательстве и политике повлияют на поставки из России в ЕС. При этом если в нашей стране фокус был на изменениях в Евросоюзе,<sup>11</sup> то

за рубежом одинаково пристально следили и за изменениями в Евросоюзе (в особенности, за антiconкурентным расследованием против Газпрома,<sup>12</sup> за изменением в характере ценообразования<sup>13</sup>), и за трансформациями в Москве (в т.ч. за стратегиями официальных властей и российских компаний).<sup>14</sup> Исследовались и модальности Энергетического диалога.<sup>15</sup>

Особой привлекательностью также пользовалось изучение различных способов обойти территорию России при транспортировке газовых ресурсов, особенно из Каспийского региона, в т.ч. через территорию Турции.<sup>16</sup>

Наконец, отметим, что в отличие от России, присутствовали в зарубежной литературе и исследования вопросов энергоэффективности, возобновляемых источников энергии, снижения парниковых газов как сфер сотрудничества Москвы и Брюсселя. Однако внимание им уделялось мало, де-факто, по остаточному принципу.<sup>17</sup>
